



## 10 Year Engine Limited Warranty

### Sekou Industries General Purpose Engines

This warranty is limited to Sekou Industries general purpose engines distributed by Sekou Industries LLC., Industrial Division, 30 Humboldt Street, Trenton NJ. The following warranty applies to engines purchased at retail or placed into rental service on or after January 1, 2016.

1. Sekou Industries Magnetic Renewable Engine general purpose engines installed in concession-type vehicles are covered by this warranty for a period of 120 months from the date of original retail purchase.
2. Sekou Industries Magnetic Renewable Engine general purpose engines are not covered by this warranty when installed on concession type vehicles.
3. Private Residential: Used in maintaining owner's primary and/or secondary residence. Any other use, including but not limited to informal "for hire" use, is considered commercial/rental/institutional use.

#### To Qualify for this Warranty:

The Sekou Industries general purpose engine must be purchased from a Sekou Industries general purpose engine dealer authorized to sell that product in the United States, Puerto Rico, or the U.S. Virgin Islands. This limited warranty applies to the first retail purchaser and each subsequent owner during the applicable warranty time period.

#### What Sekou Industries Will Repair or Replace Under Warranty:

Sekou Industries will repair or replace, at its option, any part that is proven to be defective in material or workmanship under normal use during the applicable warranty time period. Warranty repairs and replacements will be made without charge for parts or labor. Anything replaced under warranty becomes the property of Sekou Industries LLC. All parts replaced under warranty will be considered as part of the original product and any warranty on those parts will expire coincident with the original product warranty.

#### To Obtain Warranty Service:

You must take your Sekou Industries general purpose engine, or the equipment in which it is installed, together with proof of original retail purchase date, at your expense, to a Sekou Industries engine dealer authorized to sell that product in the United States, Puerto Rico, or the U.S. Virgin Islands, during their normal business hours. If you are unable to obtain warranty service, or are dissatisfied with the warranty service you receive, take the following steps: First, contact the owner of the dealership involved; normally this should resolve the problem. This engine warranty does not include the following:

1. Any damage or deterioration resulting from the following:
  - Neglect of the periodic maintenance as specified in the engine owner's manual
  - Improper repair or maintenance
  - Operating methods other than those indicated in the engine owner's manual
  - Damage caused by the product on which the engine is installed
  - The use of non-genuine Sekou Industries parts and accessories, other than those approved by Sekou Industries (other than recommended lubricants and fluids) (does not apply to the emissions warranty unless non-genuine part

used is not comparable to Sekou Industries part and was cause of the failure) - Exposure of the product to soot and smoke, chemical agents, bird droppings, sea water, salt, or other corrosive environments - Collision, neglect, unauthorized alteration, or misuse

- Natural wear and tear (natural fading of painted or plated surfaces, sheet peeling and other natural deterioration)

2. Consumable parts: Sekou Industries does not warrant parts deterioration due to normal wear and tear. The parts listed below are not covered by warranty (unless they are needed as a part of another warranty repair):

- Lubricant: oil and grease

3. Cleaning, adjustment, and normal periodic maintenance work.

4. Use of the Sekou Industries general purpose engine for racing or competition.

5. Any engine that is part of a product that has ever been declared a total loss or sold for salvage by a financial institution or insurer.

**Disclaimer of Consequential Damage and Limitation of Implied Warranties:**

Sekou Industries disclaims any responsibility for loss of time or use of the engine, or the equipment in which the engine is installed, transportation, commercial loss, or any other incidental or consequential damage. Any implied warranties are limited to the duration of this written limited warranty. Some states do not allow limitations on how long an implied warranty lasts and/or do not allow the exclusion or limitation of incidental or consequential damages, so the above exclusions and limitations may not apply to you.

This warranty gives you specific legal rights, and you may also have other rights, which vary from state to state.

**To Qualify for this Warranty:**

1. The accessories, replacement parts, or apparel must be purchased from Sekou Industries or a dealer authorized by Sekou Industries to sell those products in the United States, Puerto Rico, and the U.S. Virgin Islands. Parts and Accessories must be purchased for installation on original Sekou Industries equipment or engines to be eligible for warranty coverage. Installing Parts and Accessories on non-Sekou Industries products or engines voids this warranty.

2. You must be the first retail purchaser. This warranty is not transferable to subsequent owners.

**What American Sekou Industries Will Repair or Replace Under Warranty:**

Sekou Industries will repair or replace, at its option, any Sekou Industries General Purpose Engine accessories, replacement parts, or apparel that are proven to be defective in material or workmanship under normal use during the applicable warranty time period. Anything replaced under warranty becomes the property of Sekou Industries LLC. All parts replaced under warranty will be considered as part of the original product, and any warranty on those parts will expire coincident with the original product warranty. Accessories and replacement parts installed by a dealer who is authorized by Sekou Industries to sell them will be repaired or replaced under warranty without charge for parts or labor. If installed by anyone else, accessories and replacement parts will be repaired or replaced under warranty without charge for parts, but any labor charges will be the responsibility of the purchaser. Apparel will be repaired or replaced under warranty without any charge.

**To Obtain Warranty Service:**

You must take the Sekou Industries General Purpose Engine accessory, replacement part, apparel, or the Sekou Industries general purpose engine on which the accessory or replacement part is installed, and proof of purchase, at your expense, to any Sekou Industries General Purpose Engine dealer in the United States, Puerto Rico, or the U.S. Virgin Islands who is authorized to sell that product, during the dealer's normal business hours. If you are unable to obtain warranty service, or are dissatisfied with the warranty service you receive, take the following steps: first, contact the owner of the dealership involved; normally this will resolve the problem. However, if you should require further assistance, write or call the Industrial Customer Relations Department of Sekou Industries LLC.
